THE BOOKS HAVE BEEN DOWNLOADED FOR FREE MORE THAN 2 MILLION TIMES. THE CENTER IS NOW COLLABORATING WITH THE NATIONAL LIBRARY OF ISRAEL, YIVO, AND THE NEW YORK PUBLIC LIBRARY TO DIGITIZE THE REST OF YIDDISH LITERATURE ALONG WITH JOURNALS AND PERIODICALS.
